- In the event the undersigned fails to timely pay any invoice, the undersigned agrees to pay a monthly finance charge of 2% per month on the unpaid balance thereof.
- Past due balances can result in the undersigned's account(s) being put on hold and all credits, pending, warranty claims, and open orders will be delayed. Tele-Lite, Inc. will not accept any other orders on open account until the past due balance is paid. Open warranty claims and credits will not be considered until payment is made in full and the account is current. The support of product may require Tele-lite,Inc. to provide service part shipments directly to end user.
- In the event that it is necessary to place the account with a collection agency or attorney, the applicant agrees to pay all collection costs and attorney fees in addition to all other sums due.
- This application shall be governed and construed by the laws of the STATE OF NEW YORK. If any provision or any part of any provision of this application is hereafter held invalid or unenforceable, the remainder of this application shall not be affected thereby and to this end the provision of this Agreement are declared severable. The parties consent to the jurisdiction of the State of New York and to bring all claims of any nature in the County of Monroe, State of New York.

If credit is extended, Tele-Lite,Inc. is hereby authorized and directed to continue or discontinue with or without notice, in their sole discretion, such line of credit in any amount or amounts determined by Tele-lite, Inc. in their sole discretion and with or without notice to place this amount on a prepay basis and/or refuse sales entirely.
- Notwithstanding any corporate title listed below, in consideration of any extension of credit provided by Tele-Lite,Inc. the person(s) executing the Credit Application on behalf of the applicant personally, individually, and jointly and severally guaranty payment of applicant's past, present and future obligation to Tele-Lite, Inc.
- The undersigned warrants that the above agreement has been carefully read and the Applicant understands the terms and conditions hereof completely. The Applicant certifies that all the information supplied is true and correct in all material respects. The undersigned acknowledges that Tele-lite,Inc. will rely on the truth and accuracy of the information provided in this Application in considering the applicant's credit application.
